## General Information

The Federated Logic Conference 2026 (FLoC 2026) will take place in Lisbon, Portugal, in July 2026.

Registration will open in February 2026 and is mandatory for all participants, including speakers, workshop attendees, and Summer School participants.

By completing the registration process, participants agree to the present Terms and Conditions.

## Registration Categories & Deadlines

### 2.1 Conference Registration

Early Bird Registration: until 15 May 2026

Late Registration: until 13 July 2026

### 2.2 Workshop Registration

Early Bird Registration: until 1 June 2026

Late Registration: until 13 July 2026

### 2.3 Summer School Registration

Early Bird Registration: until 1 June 2026

Late Registration: until 6 July 2026

Registrations received after the applicable deadlines will not be accepted.

## Registration Process & Payment

All registrations must be completed online via the official FLoC 2026 registration platform.

Registration is only considered confirmed after full payment has been received.

All fees are quoted in EUR (€).

Any bank charges or transfer fees are the responsibility of the participant.

## Changes to Registration

Participants may request changes to their registration (e.g. category upgrade, additional workshops) subject to availability and potential price differences.

## Cancellation Policy

### Cancellation by the Participant

All cancellations must be communicated in writing to the FLoC 2026 Secretariat.

The following cancellation conditions apply:

Until 30 April 2026:

— Full refund of registration fees, minus administrative costs (50€).

From 1 May to 15 June 2026:

— 50% refund of the registration fee, minus administrative costs (50€).

After 15 June 2026:

— No refunds will be issued.

Non-attendance at the event does not entitle the participant to any refund.

## Transfer of Registration

Registration may be transferred to another participant from the same institution or organisation, subject to approval by the Organising Committee. Transfer requests must be submitted in writing no later than 30 June 2026.

## Cancellation or Modification of the Event

The Organising Committee reserves the right to modify the programme, speakers, dates, or venue if necessary.

The Organising Committee shall not be liable for any costs incurred by participants, including travel or accommodation expenses.

## Liability

The Organising Committee is not responsible for:

- Personal injury
- Loss or damage to personal belongings
- Any indirect or consequential losses

Participants are advised to take out appropriate travel and health insurance.
